WOMEN RECEIVE SUPPORTIVE SERVICES INCLUDING WARM MEALS, HOT SHOWERS, CLOTHING AND PERSONAL HYGIENE ITEMS AND CAN TAKE ENRICHMENT CLASSES. ALL SERVICES ARE CENTERED AROUND CASE MANAGEMENT TO ASSESS EACH INDIVIDUAL'S NEEDS AND TO CONNECT EACH GUEST WITH OTHER SERVICE PROVIDERS. IN 2021, GFW STAYED OPEN THROUGHOUT THE PANDEMIC, PROVIDING SERVICES TO 371 INDIVIDUALS INCLUDING 11,814 MEALS, 1,279 HOT SHOWERS, 1,273 VISITS TO THE CLOTHES CLOSET, AND 1,197 CASE MANAGEMENT SESSIONS. FIFTEEN WOMEN ENTERED AFFORDABLE HOUSING THROUGH PARTNER ORGANIZATIONS.

GFW PROVIDES THREE MEALS A DAY, SEVEN DAYS A WEEK AND CASE MANAGEMENT FOR THE SINGLE WOMEN IN RESIDENCE.
