Day Care Center: Service accomplishments include providing day care services to homeless and at-risk women once each week on Tuesday that includes a caring community and hot nutritious meal and sack lunches to go, free clothing, free personal care items such as soap, sanitary supplies, sunscreen, sleeping bags, tents, tarps, etc., emergency transportation assistance in the form of fuel and bus vouchers, and laundry and shower vouchers. We coordinate access to other service providers for health and well-being workshops, flu shots and diabetes screening. Over 400 women were served in 2016.
